- The task force's mission is to combine expert education and research, public input, and regional ideas and initiatives to determine critical pathways for possible short and longterm policy solutions.
- Encourage jurisdictions to file amicus briefs and provide support for the City of Costa Mesa who is in litigation and/or appealing unfavorable rulings.
- Establishing a commonly accepted ordinance draft to protect cities and communities.
- Supporting legislative proposals and reforms that protect cities and communities.

Local Law Enforcement Update

- Bifurcating complaints that can be enforced versus ones that cannot be enforced.
- Standardizing enforcement across agencies

Costa Mesa Litigation Update

- Request for rehearing was denied by the Appellate Court.
- Costa Mesa will not petition the Supreme Court to review the case.
- TASK: task force members can support this effort by filing Amicus Briefs.

Representatives from Participating Cities

- A commonly accepted local ordinance template could be further developed with the support of the Association of California Cities and the California League of Cities.
- The City of Mission Viejo adopted a local ordinance establishing a business registry for sober living and treatment homes to establish another reasonable method for accountability and enforcement.

- We are collaborating to ensure the amended. language meets the Task Force's objectives.
